



LGBTQ Asylum-Seekers

This month we celebrate Pride to commemorate the Stonewall Riots, and to celebrate, uplift, and raise awareness of issues affecting the LGBTQ+ community. American Gateways represents LGBTQ+ individuals every year seeking asylum and safety in the US due to their sexual orientation and gender.

We represented John (pseudonym) an asylum case due to his sexual orientation. Growing up in El Salvador, John had a difficult childhood. He was abandoned by his father and witnessed his mother's brutal murder as a young child. John lived with relatives who, rather than offering a loving home, forced him to work on a ranch performing physically demanding and often dangerous tasks at a young age. During this period, John also suffered regular sexual abuse.

As a teenager, John made the difficult decision to leave El Salvador in search of a better life in the United States. Unfortunately, as a young adult on his own, John faced many challenges upon arrival. Over time, he became increasingly aware of his sexual orientation and came out as gay. Sadly, this only led to further harassment and abuse.

An encounter with police resulted in John being detained and placed in deportation proceedings. It was there that John attended an American Gateways presentation. Our staff attorneys helped John win permission to remain in the U.S. Now out of detention, John is looking forward to rebuilding his life and receiving the counseling and support he needs to heal from his past abuse.
