June is Immigrant Heritage Month, a time for celebrating and honoring the immigrants who have shaped this country, and this state's, progress. Today, Texas is home to some of the most diverse communities in the country. According to the U.S. Census, Texas is the 6th most diverse state in the country; Houston is the most diverse city in U.S. and Dallas is the fourth most diverse. Last Friday, we celebrated Immigrant Heritage with our annual June Fiesta in Austin. It was great to connect with so many clients, former clients, volunteers, and supporters. At the Fiesta, we recognized one of our stellar volunteers - Nick Dauster. Nick is a fluent translator, compassionate advocate for our clients, and very generous with his talent and time. Unfortunately, not everyone in Texas shares our view that diversity and welcoming immigrants is positive for our state. Just last month, there was yet another court hearing on the legality of DACA. A lawsuit brought in 2018 by a coalition of nine states, led by Texas' currently suspended Attorney General Ken Paxton, alleges that DACA is illegal because it provides benefits to DACA recipients through federal regulations that only Congress can approve. The lawsuit has been in courts for years, keeping current DACA recipients and their families in limbo and prohibiting new individuals who qualify for this protection from applying for initial DACA status. The hearing last month was the latest legal maneuvering on the case. It is very likely the lower court will rule DACA status in a vulnerable, unstable legal status.

As one DACA recipient, Eliana Fernandez, the immigrant justice director for Faith in Action, a national immigrant rights advocacy group said in the article, "I am tired of having to continue to hold my breath as DACA continues to be under threat," Fernandez said. "Every time there is a hearing or as we await a verdict, I not only have to prepare myself but also my children, my parents, my brother, and the rest of my family. This is exhausting and terrifying."

As we've pointed out repeatedly, what is needed is comprehensive immigration reform.
